## CLINICAL EXPERIENCE:

Dr Logan is a Consultant with 24 years' experience in the Countess of Chester NHS Trust, now exclusively engaged in private practice and medicolegal reporting. His expertise lies in the fields of anaesthetics, pain management, chronic and neuropathic pain, with a particular focus on adult pain relief, rehabilitation for painful conditions, and fibromyalgia.

His professional involvement encompasses the comprehensive assessment and treatment of patients with long-term pain or acute exacerbations of pain, spanning various areas such as shoulder, back, neck, neuropathic, chronic post-operative pain, and complex regional pain syndrome.

Dr Logan specialises in interventional treatments for chronic post-operative pain syndromes, as well as addressing shoulder, back, and neck pain using facet joint treatments, including radiofrequency procedures and specific techniques for sacroiliac joint pain and coccydynia.

While he maintains a broad scope of practice, he prefers to avoid highly specialised and serious psychological issues, considering himself a "general interventionist" with extensive experience in managing back, neck, shoulder pain, post-operative pain, and neuropathic pain syndromes.
