Dr Bret Claxton is a highly qualified medical professional, graduating from Aberdeen University Medical School in 1994 and achieving fellowship status with the Royal College of Anaesthetists in 1999. In 2002, he completed a Masters Degree in Medical Science and became a Fellow of the Faculty of Pain Medicine in 2014.

Within the NHS, Dr Claxton holds consultant appointments at Bradford NHS Trust, specialising in anaesthesia since 2003 and pain management since 2014. Currently, he conducts four outpatient clinics and two theatre-based interventional procedure lists monthly, dedicating two sessions to consultant-delivered Acute pain management. His expertise also extends to providing both NHS and Private Pain Management at a Private Hospital, with four sessions of outpatient activity and four theatre lists monthly.

Dr Claxton specialises in managing various chronic pain conditions, including back pain, sciatica, whiplash, CRPS, and post-traumatic and post-surgical pain. He particularly focuses on knee pain management and excels in neuromodulation, specifically the insertion of Spinal Cord Stimulators for Post Spinal Surgery Persistent Pain Syndromes, following NICE Guidance.

Dr Claxton is actively involved in professional presentations and educational roles, serving as an educational supervisor and clinically supervising advanced pain trainees. His past roles include Foundation Training Programme Director, Associate Postgraduate Dean, Interim Deputy Postgraduate Dean, and Head of School for Anaesthesia and Intensive Care Medicine at Health Education England, Yorkshire and The Humber. For the last three years, Dr Claxton has served as the Clinical Lead for Pain Services at Bradford Teaching Hospitals NHS Foundation Trust, demonstrating his dedication and leadership in the field.
