Clinical negligence cases relating to:

- Delayed diagnosis of conditions, such as:
 - Cancer
 - Inflammatory conditions
 - Serious acute conditions (e.g. infections (sepsis), appendicitis, diverticulitis, ischaemic limbs, stroke, heart attack (acute coronary syndrome), subarachnoid haemorrhage, suicide, ectopic pregnancy)
- Inadequate management of conditions, such as:
 - Long term conditions (e.g. diabetes, hypertension, kidney disease, including inadequate monitoring or review)
 - Repeat medication (e.g. medication monitoring or inadequate counselling regarding medication side effects)
 - Conditions that raise the risk of harm, such as:
 - Atrial fibrillation (AF) increasing risk of stroke
 - Pre-diabetes (increasing the risk of diabetes)
 - Hypertension (increasing the risk of heart disease and stroke)
- Covid related symptoms:
 - Long Covid
 - Extended loss of sensation (taste/smell)
 - Prolonged respiratory issues
- Operational issues in practices (e.g. reception signposting, review or action of investigation results, management of correspondence)
