His postgraduate neurology training included general neurology, neuro-imaging, clinical neurophysiology, neuro-surgery, rehabilitation medicine, intensive care, neuro-ophthalmology, neuro-psychiatry and research methodology. Over the years as a Consultant Neurologist since 1989, he delivered general neurology and specialised out-patients clinics, on-call duties for acute neurology take and ward rounds for in-patients. Dr Al- Araji has special interest in inflammatory and demyelinating neurological conditions including Multiple Sclerosis and other inflammatory conditions of the central nervous system. His other duties included teaching and supervising undergraduates of Keele Medical School during their neurology placement and postgraduate general medicine and neurology trainees.
