Mr Volpin completed his medical degree and higher specialist training in Trauma and Orthopaedics at the University of Padua, Italy, followed by advanced training in the UK at University College London Hospitals and the Princess Royal University Hospital, part of King's College Hospital. To refine his subspecialist expertise, he undertook two post-CCT fellowships in Knee Surgery and Lower Limb Arthroplasty at the Royal Derby Hospital and the Royal Bournemouth Hospital, complemented by international travelling fellowships at BC (Vancouver) and UCSF (San Francisco).

His clinical interests encompass trauma, joint arthroplasty, arthroscopic surgery, soft-tissue and sports injuries, and general orthopaedic conditions, with a specialist focus on Trauma and Lower Limb Surgery. He regularly treats both amateur and professional athletes, with particular expertise in sports injury management, return-to-play strategies, and joint preservation techniques.

Mr Volpin is the author of five book chapters and thirty-seven papers published in peer-reviewed journals.
