He later moved to a principal consultant role at Chelmsford Priory Hospital, where he regularly treated anxiety disorders, depression, personality disorders, and schizophrenia.

Dr Castle as a Consultant, runs a regional Neuropsychiatry Clinic. From 2021 his role expanded as the Liaison Psychiatrist to the Essex Pain Service, this requires assessment and management of complicated addiction and personality/psychiatric disorders in the context of chronic pain that allows him to diagnose and treat primary pain disorders.
