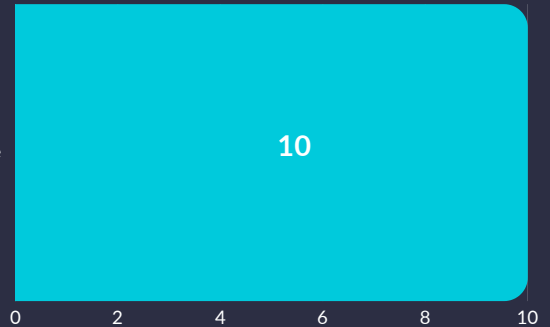

CASES RELATING TO:

Ocular conditions/deterioration and pathologies

- Signs and symptoms of conditions such as:
 - Glaucoma
 - Cataract
 - Macular degeneration
 - Diabetic eye disease
 - Keratoconus
 - Dry eye disease
 - Defects in vision
 - Signs of injury
 - Abnormality (asthenopia/visual discomfort, conjunctivitis (allergic, bacterial, viral), corneal abrasion/scarring)
- Appropriateness and timeliness of referral to ophthalmology or other services
- Whether monitoring intervals were reasonable
- Problems with general health/tumours:
 - Neurological issues
 - High blood pressure
 - High cholesterol
- Floaters
- Contrast sensitivity
- Visual fields (screening-level interpretation)
- Binocular vision and depth perception
- Glare sensitivity
- Visual fatigue and asthenopia
- Contact lens practice:
 - Hygiene advice and compliance
 - Risk factors for infection or complications
 - Whether care met accepted professional practice

• Refractive errors:

- Degree and significance of refractive errors
- Appropriateness of prescribed spectacles
- Visual function with/without correction (impact on daily activities; reading, driving, screen use)
- Myopia (near-sightedness)
- Hyperopia (Farsightedness)
- Astigmatism
- Presbyopia (age-related loss of close-up focusing)
- Diplopia (double vision)
- Amblyopia (lazy eye)
- Colour blindness
- Diabetic retinopathy

General optometric matters

- Adequacy of:
 - Case history taking
 - Visual acuity testing
 - Binocular vision assessment
 - Ocular health examination (anterior/posterior segments)
 - Appropriateness of tests (based on patient age/symptoms/risk factors)
 - Interpretation of clinical findings
 - Record-keeping quality and completeness
 - Compliance with professional guidelines
 - Whether a visual condition could plausibly be related to an alleged event (e.g. trauma, delayed diagnosis)
 - Whether deterioration is consistent with normal progression
