

Dr Breen was appointed Consultant in Intensive Care Medicine and Anaesthesia at Leeds Teaching Hospital Trust (LTHT) in 2005, he also works in both Leeds General Infirmary (LGI) and St James's University Hospital.

Dr Breen has an excellent record in leadership and management, having been Lead Clinician for Adult and Critical Care in SJUH for five years. Then a Clinical Director for Adult Critical Care across all LTHT hospitals for seven years. His serves was led to a CQC "Outstanding" rating in 2018 and have comprehensive experience in delivering, developing and leading high-quality service. This was recognised in the National Clinical Excellence awards rounds in 2019 and 2023.

A national leadership role, he has been elected member of the executive council and board of trustees of the Intensive Care Society (ICS) with responsibilities as chair of the Professional Standards Division and Honorary Secretary. He is a co-founder of the ICS education programme in point-of-care ultrasound, leading this initiative to become the world's first modular training programme for intensive care professionals.
