

- Delayed diagnosis of conditions, such as:
  - Cancer
  - Heart disease
  - Diabetes
  - Serious acute conditions e.g infections
    - o Sepsis
    - o Appendicitis
    - o Diverticulitis

- Inadequate management of conditions such as:

  - Hypertension (increasing the risk of heart disease and stroke
  - Polypharmacy taking too many medicines in frail and elderly that result in falls, injury, confusion and hospital admission
- Operational issues in practices reception
  - Signposting
  - Review or action of investigation results
  - Management of correspondence
