He holds Approved Clinician status and can undertake Mental Health Act Assessments as a Section 12 Approved Doctor. Dr Loughlin offers genetic testing through myogenes and ongoing cognitive testing in collaboration with Creyos (formerly Cambridge Brain Sciences) to track changes in cognitive function over time.

His clinical approach is holistic, non-judgemental and not just focused on a diagnosis. He works in partnership with patients with respect and empathy, and recommends psychological treatment before medication when safe to do so.

Dr Loughlin led the developments to the opening of the Berkshire Memory and Cognition Research Centre based at the University of Reading in 2014. He was also a principal investigator in several dementia research studies whilst working in his NHS post.
